## **HOW DANGEROUS GOODS ARE CLASSIFIED**

Dangerous goods are materials that can pose a risk to human health, safety, salubrity and damage to the environment. Currently there are 3 classification criteria according to the type of transport: land (ADR), sea (IMO), air (IATA) rail (RID).

For all kind of transport: road, sea, river, air and rail. The grouping by type of dangerous goods has been elaborated by the United Nations Committee of Experts on the Transport of Dangerous Goods and is divided as follows.
